# ELECTRONICS PRODUCT STEWARDSHIP IN ALASKA: BACKGROUND



In 2016, with support from the USEPA, SWAT began exploring product stewardship in other states and Canada to identify potential models that could apply to both rural and urban electronics disposal circumstances. A Product Stewardship Workgroup comprised of multiple stakeholders from across the state was convened to identify key issues and draft the basic principles needed for a program that could work for both demographics. A draft program outline resulted and initial public forum education began. The intervening pandemic stalled that effort, but in Fall 2021, SWAT contracted PSI, a national product stewardship subject matter expert, to

help them develop the program's details needed for successful legistlaion, and to guide them through a successful process.

PSI uses 16 key "Elements" critical to successful legistlation, including which electronics are covered, how manufacturers will ensure convenient collection access for all Alaskans, and how funding enters the program and for what purposed it is used. Working together with SWAT's knowledge of Alaska's waste management and PSI's expertise, these Elements were adapted to Alaska and then, via several meetings, presented to an Alaska Electronics Stewardship Committee for input and revision. The Commitee, established for this purpose, was comprised of representatives from 13 rural and urban entities, including local governments, Alaska Tribal Consortia, and waste transporters. Starting in May 2022, PSI and SWAT interviewed additional stakeholders in a one-on-one format to obtain more nuanced and entity specific input.
